How to Enter: Fill out an application at www.Detox.com/scholarship/ (the "Contest Website").

- 2. **Contest Duration**: The contest ends on 7/31/2026 (the "Deadline"). All applications and essays must be submitted prior to the Deadline to be considered for the contest. Once the Deadline has passed, no further entries for the contest will be accepted. Detox.com will announce the winners on 8/30/2026. All entries must be typed, double-spaced, and saved as a Word Doc or PDF. Do not add pictures or graphics to essay Word Doc or PDF. Essays not meeting the word count requirement will be eliminated. The essay title or added footnotes do not contribute to the total word count. A contestant's teacher, counselor, or parent may check the essay for punctuation, grammar, and/or spelling, but the essay *MUST*

BE the original work of the student making the submission. Contestants will be judged based on their essay alone. AI-generated essays will not be accepted.
